## DECLARER PLAY by Audrey Grant


When dummy comes down, it is important declarer makes a plan *before* playing to the first trick. Use the ABCs of declarer play to help you.

The first step is to *Assess the Situation* – count the number of winners or losers we have and compare the total to the number of winners we need or losers we can afford. When we need to establish extra winners or eliminate losers, we move to the second step, *Browse Declarer's Checklist*, for the various techniques. The final step is to *Consider the Order*, deciding how to put it all together. In this step, there are a number of considerations, including: drawing trumps, managing entries, watching out for the opponents, taking losses early, and combining chances.

Let's take a look at the following deal and apply the principles.

DEALER: NORTH  
VUL: E-W  
DECLARER: EAST

Pass Pass Pass



### The Auction

You hold this hand as South. Partner opens 1♦ as the dealer. East passes.

With a four-card heart suit and 11 high-card points, you respond 1♥. West passes. Partner rebids 2♣. East passes. With a balanced hand, bid 2NT to show your strength and invite game. West passes, and partner raises to 3NT. Everyone passes.

You are now the declarer in 3NT.

## Making a Plan

West leads the ♠2.

Making 3NT will require nine tricks. It's time to make a plan.

In a notrump contract, begin by counting sure winners. You start with one sure spade winner, one sure heart winner, three sure club winners, and no sure diamond winners because the opponents hold the ♦A. That's a total of five sure winners, and you need four more.

Where could the additional tricks come from?

The opening spade lead presents an additional potential trick in the suit. If ♠K is in the West hand, declarer can win with the ♠Q in hand. If the ♠K is in the East hand, then declarer's ♠Q will be promoted to a winner.

There is a potential for a fourth club trick if the opponents' six clubs divide 3-3.

Four tricks can be established in the diamond suit. Once the ♦A is driven out, the rest of the diamond suit will be promoted into winners.

This looks pretty straightforward. In fact, South might take ten or eleven tricks on this deal. Let's see how the play might go.

### Possible Play

West has led the ♠2. Let's suppose South decides to establish a second spade trick by playing low from dummy. The ♠4 is played. East wins the ♠K, establishing the ♠Q as a winner.

However, East shifts to the ♥K. This is a dangerous shift. Without sufficient strength in declarer's heart suit, the opponents might be able to take three or more heart tricks plus the ♦A!

In fact, that's what happens with this deal:

After East wins the ♠K, by shifting to the ♥K, East-West will take three heart tricks and the ♦A – a total of five tricks. Declarer will be down one.

It had looked like North-South had plenty of tricks. What went wrong?

### Consider the Dangers

There are enough potential winners to make the contract – *but only if we watch out for the opponents*. South must avoid the danger of letting the opponents establish and take five winners before South can take nine.

Hearts is declarer's weak suit. Without enough length and strength in the suit, once declarer is forced to play the ♥A, the opponents can establish heart winners and defeat the contract.

How can South make sure the opponents cannot switch to hearts effectively?

#### Win the ♠A at trick one!

By winning the first trick, South can avoid the danger of a heart shift by opponents. However, doing so might allow the opponents to take spade tricks. After the ♠A is gone, South will remain with only the ♠Q-10. Indeed, if East holds the ♦A, a further spade lead would trap South's ♠Q-10 and result in losing several spade tricks if West has the ♠K-J.

However, the heart suit is the greater danger. If East wins the ♠K and switches to hearts, you might lose five or more tricks.

If you win the first trick with the ♠A, the opponents should be able to take at most three spade tricks plus the ♦A. How can you be sure?

### Use the Clue

The clue is in the opening lead. Assuming West's lead is fourth-highest, the ♠2 is the lowest spade, so West presumably started with exactly four spades.

Eight spades are missing. So, if West has four, East also has four. After the ♠A is taken, the opponents will be able to take no more than three spade tricks plus the ♦A.

You can afford to lose four tricks, so the contract should be secure if you win the ♠A at trick one.

### Recommended Play

Let's replay the hand with this strategy in mind. West has led the ♠2.

Win with the ♠A. Next, develop the diamond suit by playing a low diamond from dummy to the ♦10. Whenever East wins the ♦A, East leads a spade through your ♠Q-10. West wins three spade tricks, as you have expected.

After that, it doesn't matter what West leads. You have the ♥A, three club winners, and the diamond tricks. Your 3NT contract is safe!

## Summary

Often, you can guarantee an extra trick or two in the suit of the opening lead by giving the opponents the chance to win the first trick. However, it is not always safe to do so. You must consider the dangers.

On this deal, playing low from dummy ensured a second trick in spades but put the contract at risk. East could win the first trick and shift to hearts.

Sometimes, it is safer to take the first trick, even if it might sacrifice a trick in the suit. In this deal, it was safer to lose spade tricks than heart tricks.

Analyzing the opening lead is the key. West's ♠2 lead meant the opponents could take at most three spade tricks. In contrast, playing low from dummy risked losing the ♠K, ♦A, and three or more heart tricks.

Next time you are declarer, make a plan and follow the ABCs of declarer play. You will be rewarded with your careful considerations.





# Bergen Tips from Marty Bergen

- 1) Always think about how many trumps the opponents have and how they are likely to divide.
- 2) When to lead a trump: RHO opens a major, his partner never supports him, opener bids a second suit, which becomes trump. Dummy is probably short in declarer's first suit so you should be eager to lead a trump.
- 3) Two of the most important principles of The Law of Total Tricks are: With 10 trumps, be eager to compete to the four level. When in doubt, bid 4 spades over 4 hearts.
- 4) Consider whether to draw trumps first. Unless you're 100 percent sure, don't do it.
- 5) If the Rule of 11 contradicts the cards in view, you can be sure partner has led top of nothing rather than 4th best.
- 6) If the defenders are not likely to ruff anything, postponing the drawing of trumps is not a problem.
- 7) When partner opens 1NT, do not get carried away when you have a flat 16 HCP. A raise to 4NT is enough.
- 8) Every player has heard, "When in doubt, lead trump." Obviously, if your other suits are "unleadable," you would lead a trump but the above statement is not very helpful. I much prefer the following guideline: The best time to lead a trump is when you are NOT in doubt."
- 9) Even when you're not taking a finesse, it often matters which hand leads the suit.
- 10) After partner overcalls at the one level, a new suit should not be forcing.
- 11) Play the honor from the short side first applies to the declarer AND the defenders.
- 12) If the opponents have the balance of power and a fit, your only hope may be to lead a short suit.
- 13) If partner doubles their slam, assume he has a void and try to "find" it.
- 14) If RHO bids or doubles after partner's Jacoby transfer, you don't have to bid.
- 15) Two things to try to memorize: The opening lead and dummy's distribution and honor cards.



It always makes me feel sick

## Starting the Game – Bidding and Playing

### 1. The Opening Bid

Once the deck of cards has been dealt (13 cards each), players pick up their cards, count them, and sort them into suits, highest to lowest.

Count points as follows: (HCP means High Card Points)

Hand Evaluation		
Ace	4 points	HCP
King	3 points	HCP
Queen	2 points	HCP
Jack	1 point	HCP
5 <sup>th</sup> card or more in one suit	1 point each	

Example:



The dealer is the first player who has the opportunity to make a call (pass or bid).

The bidding and playing of the game proceeds to the left (clockwise).

In order to start the bidding, a player should have 12+ points.

(There are some exceptions to this, but for now, it is a good rule to follow.)

If you do not have 12+ points, you should pass.



On rare occasions, all four players will pass in the first round and the game is "passed out."

Note: It is highly recommended to use bidding boxes. Players will learn faster. First, they can see all the bids available to them. Second, the bids are placed on the table in front of each player facing the center so all players can see all the bids throughout the bidding. No time is lost by verbally repeating the sequence of bidding and asking, "What did you bid?" There is much less confusion and more time is spent on learning the game of bridge.

Note: A "Pass" is not considered a bid.

Each game has only one **Opening Bid**.

The player who opens with the first bid (does not pass) is called the **Opener**.


The player who bids higher than the Opener is the **Oversetter**.

The player who responds to his partner (the Opener) is the **Responder**.

The player who responds to his partner (the Oversetter) is the **Advancer**.

Note: Sometimes the Oversetter may be in 4<sup>th</sup> seat after the Responder.

For now, the two important positions to remember are the **Opener** and the **Responder**.



### 2. The Goal for Bidding

The final contract is established after the last bid is on the table and it is followed by 3 consecutive passes. The last bid becomes the final contract.

The goal for you and your partner is to find the best contract, which is, in order of preference:

#1 - A major suit contract (with 8+ cards in either ♥ or ♠ between you and partner)

#2 - A NT contract (somewhat balanced hands with no 8-card fit in a major)

#3 - A minor suit contract is the least desirable option, but sometimes the only good option.

**Important:** A contract in ♠, ♥ or NT requires fewer tricks and gives a higher score, compared to a minor suit contract in ♣ or ♦. This is why it is more beneficial to find a major suit contract or a NT contract, whenever it is possible, and why your first goal is to find out if you have an 8-card fit in a major suit.

Note: Refer to the **Bidding Chart** on this website for more details.

Suits are ranked from lowest to highest as follows:

Minor Suits (**♣ Clubs** and **♦ Diamonds**), then Major Suits (**♥ Hearts** and **♠ Spades**).

The highest bid available at each level is NT (No Trump).

Once three consecutive passes have occurred and the final contract is established, the bids are put back into the bidding box, and then the play of the hand begins.

### **3. Starting the Game – First Round**

The player who first bid the strain of the contract (the suit or NT) becomes the Declarer.

The player immediately to the left of Declarer, Declarer's Left-Hand Opponent (abbrev. LHO), will make the "opening lead."

Errors are sometimes made as to which player makes the opening lead.

To prevent making the opening lead in error, here are the recommended steps to follow, in this order:

The player making the opening lead should decide on the suit and card to play, based on the bidding and the contents of his/her hand.

Before selecting the card, the player may ask for a review of the bidding from one of the opponents.

The player should take his/her chosen card and place it face down on the table, still holding it.

The player should ask, "Is it my lead?" to ensure it is, in fact, his/her lead.

Another option is to say, "Any questions, Partner?"

- This allows any player an opportunity to stop the player from leading, if it is not his/her turn.
- If it is not this player's turn to lead, s/he can put the card back into his/her hand (no one has seen the card) and the situation has been corrected without any problem.
- If it is the player's turn to lead, then the card is turned over and the game begins. The player is not allowed to change his/her mind on which card to lead at this point.

As soon as the opening lead is made, the partner of the Declarer displays the dummy hand on the table, placing the trump suit on dummy's right (Declarer's left), towards Declarer. Other suits should be placed alternating red and black. When in a NT contract, usually the order of suits, from left to right (Declarer's viewpoint) is spades, hearts, clubs and diamonds, though it is not imperative. Sample dummy hand ↓

Players must "follow suit" unless they have no cards in the suit which was led.

Declarer will call for the card to be played from the dummy hand. The "dummy" will play the card as requested.


Each round that you play and win is called "taking a trick."

There are 13 rounds in each game (13 tricks).

A "book" is considered 6 tricks and is the basis on which to determine the number of tricks required to make your contract.  
(Book + contract level = number of tricks req'd.)

E.g., To make a contract of 1♥, you must take 1 trick over book (6 + 1 = 7 tricks in total).

To make a contract of 4♥, you must take 4 tricks over book (6 + 4 = 10 tricks in total).  
Refer to the Bidding Chart to see the number of tricks required to make each contract.



Take notice of the following information:

Bonus points are given for reaching game level and higher.

A game of 4♠ or 4♥ (Major Suit) requires 25+ points (10 tricks).

A game of 3NT requires 25+ points (9 tricks).

Fewer tricks are required for 3NT compared to 4♠ or 4♥, but 3NT can be more difficult to make.

A game 5♦ or 5♣ (Minor Suit) requires 29+ points (11 tricks).

A minor suit contract is less desirable than a major suit or NT contract.

The score is higher for bidding and making a NT or major suit contract, compared to a minor suit, and fewer tricks are required.

Most often, you will be able to reach only a Partscore (any contract below Game level).

The highest scores are obtained by bidding and making a Slam contract.

A Small Slam is reached by bidding and making a contract at the 6 Level (any suit or NT).

A Grand Slam is reached by bidding and making a contract at the 7 Level (any suit or NT).

At the end of the first round, each player keeps his/her played card and places it face down at his/her own side of the table. If you have been playing social bridge, you may be accustomed to playing a card by placing it (or throwing it) in the middle of the table and the winner of the trick taking all the 4 cards for him/herself. It may require concentration and some time to break this habit.

The card is placed "straight up" (pointing towards the winner and partner) if winning the trick.

The card is placed "sideways" (pointing towards the opponents) if losing the trick.

Easy way to remember: "Stand up -- you win; lie down -- you lose." (See picture below.)

#### **4. Continuing the Game (12 more rounds) and Finishing the Game**

The player who won the first trick, now leads the first card for the next round.

This continues as each round is played.

Helpful Hint: If your partner does not follow suit, ask this question: "No more spades, partner?" (replace the word, "spades," with whichever suit was led). If s/he has a card of that suit in his/her hand and fails to play it, this is called "reneging" or "revoking." If this mistake is caught immediately, the penalty is minimal. If playing in a sanctioned game, it is best to call the Director. If the mistake is not caught immediately, at the end of the game, a 1- or 2-trick penalty could be assessed on the offending side, depending on the situation.

When the game is finished, all players should count their tricks and verify that the count is correct and agreed to by all before moving their cards in any way.



This display shows how cards are placed in front of a player whose side won the first 4 tricks, lost the next 4 tricks, won the next 2, lost the next 2 and won the final trick. This player (and his partner) won 7 tricks.

Scores should be calculated and recorded.

If using prepared boards, players should put their cards back into the board slot from whence they came. If playing "social bridge," cards are shuffled and the dealer distributes the hands for the next game.

## **Some common bridge terms and other information that is helpful to know:**

Void – no cards in that suit

Doubleton – two cards in a suit

Singleton – one card in a suit, sometimes referred to as a “Stiff”  
(e.g., a “Stiff Ace,” means a singleton Ace.)

Balanced Hand – no voids, no singletons, maximum of one doubleton

Stoppers – a stopper in a suit is a high card that will stop the opponents from running their suit. An Ace is always considered to be a stopper. These are also considered to be stoppers: a King in a doubleton suit or longer, a Queen in a suit with 2+ other cards, a Jack in a suit with 3+ other cards.

Judgment is needed to assess what you need to stop a suit safely, especially if opponents are bidding.

Stoppers are significant when playing in a NT contract. Stoppers need to be considered when deciding whether a NT contract is “safe” above the 1 level and are important when settling for a 3NT contract (game level) or higher.

Honor cards – Ace, King, Queen, Jack

Spot cards - any card below an honor card (some consider the Ten to be an honor)

LHO – Left-hand opponent

RHO – Right-hand opponent

A notation such as 3+ cards means 3 cards or more; 12+ points means 12 points or more.

Designation of seats:

There are 4 seats at a bridge table.

The dealer is considered the 1<sup>st</sup> seat. (The dealer changes for each round.)

The next seat, moving clockwise, is the 2<sup>nd</sup> seat, then 3<sup>rd</sup> seat and the last player to bid or pass in the first round is designated the 4<sup>th</sup> seat.

Bidding rules can change slightly, depending on which seat opens the bidding.

For example, a player sitting in 3<sup>rd</sup> seat after two passes may open “light.” That means opening with fewer than 12 points. More information on this later.

For now, if you prefer, always have opening points to open the bidding.

**Partnership Agreement** – Many different bidding methods and philosophies are used in bridge. Whatever set of conventions and practices which you and your partner agree to use is called “partnership agreement.”
