A Mansion's Long Journey: From Redwood Cottage to Gilbert's Restaurant 1885 - 2001 ... a history ...

In a community where wealth has always been conspicuously displayed, the 1885 mansion now known as "Gilbert's" has undergone an extensive renewal. Originally called the "Redwood Cottage," the 30 room mansion was built as a summer home residence for the family of industrialist Robert H. Baker of Racine. Mr. Baker was an early stockholder in the JI Case Co. and later a prominent politician. His father, a prominent attorney and founder of the Baker and McKenzie Law Firm of Chicago, once owned a beautiful mansion next door to the south (which has been demolished for about 10 years).

Emily Baker, wife of Robert Baker, played an important part in the design of the whimsical "Queen Anne" style Victorian home. Robert died at the very young age of 43 before the home was completed, leaving Emily the daunting task of designing and overseeing the construction of this beautiful mansion.

However, Robert, during his relatively short life accomplished much. By the year 1882 Robert Baker had served as a school commissioner, alderman, mayor and was twice elected to the state senate. He was once elected the republican candidate for lieutenant governor and by age 24 owned over 25% of JI Case. Robert and Emily Baker were devout family people with great interest and concern for their community and country. They loved Lake Geneva, as we discovered after reading many letters written to friends and family back home in the east. The letters included poetic descriptions of the beautiful area around the lake and took great pains to name the trees, plants and animals of the region.

The warmth and respect of this family can be felt throughout the home with its rich woods of cherry, walnut, oak, maples, mahogany and fir. The unusual one-of-a-kind craftsmanship found in the 13 hand carved fireplaces which are inlaid with the original Mediterranean tiles are now lit nearly every night in winter for guests. The grand solid cherry stair case extending the full three stories of the great hall is breathtaking and only to be out done by the magnificent parquet floors and massive oak doors ornamented by intricate detailed brass hinges and closures, each one different in pattern and design. The open foyer with its stained glass windows and crystal chandeliers give a cathedral-like appearance to the great hall. The bar having been the family formal dining room remains almost in its original state with the exception of the cherry and marble bar addition. Then there are the dining rooms each with their own unique fireplace, ornate mantels, intricate Rocco plasterwork on walls and ceilings, antique mirrors and sparkling crystal chandeliers. A pair of huge matching oak doors lead out to the wrap around porch with its panoramic view straight up Lake Geneva. Truly a sight to behold.

In summer the home stands proud- sandwiched between the hotels on the prominent "Wrigley Drive". Her seven different patterns of fancy cut redwood shingles, copper roof and brightly painted gingerbread trim are often photographed by tourists and artists alike. Her tall tower a spectacle in the harbor among the municipal boat area, the Riviera Ballroom and famous boardwalk. Her gardens designed by one of her owners (an award winning landscape architect) are irresistible to passers by. Filled with many of the areas indigenous flowers and grasses much loved by her original owners. The gardens have quickly become a most desired spot for weddings and the renewing of vows. A kitchen garden offers fresh herbs for the evening fare picked daily by the chef and kitchen staff. Fall finds her surrounded by autumns color turning the view for diners into a collage of brilliant reds, yellows, orange and brown. The water fowl fill the shore and air with sound and movement causing diners to linger long sipping wine from their award winning wine list or perhaps cappuccino made with fresh organic coffee beans ground to order. Winter is absolutely magical at the mansion. All trimmed, thousands of lights turn her stately form with "witches cap tower" and "gingerbread" trim into a "fairy tale like castle". Upon entering, one will hear the live music of strings and woodwinds, harpists and piano. Her walls responding with the music of the holidays. The rooms and halls filled with boughs, wreaths, trees and trimmings. A family collection of angels, bright ornaments and flowers adorn every corner. A holiday treasure chest! The third floor "known as the servant's quarters" for at least a month in advance becomes "the elves workshop" Busy hands construct, glue, weave and tie till all is ready for December 1. Then we pull out all the stops with Holiday Tea, live music, Gilbert's Gift of Gold, extravagant holiday meals and a gala New Years Eve. January also brings Winterfest. February we feature special wine dinners, and a romantic Valentines day celebration. Spring bursts forth with blossoms galore! Tulips, daffodils, magnolia and flowering crabs to name a few fill the front lawn, gardens and lakes area complimenting her grandness from every angle. The lake stretches out on clear view of her creating a most welcome site.

Great declarers are always on the lookout for the best percentage plays, but sometimes a lack of entries forces declarer into a weaker line of play. Benito Garozzo was South on this hand from a Bermuda Bowl. His 1C opening showed a strong hand and 1D was negative. After East bid 1S, Garozzo decided not to show his diamond suit, but rebid notrump instead. The 2S cuebid by partner was Stayman.

Because East did not double 2S, West decided to try a surprise heart lead. This turned out very well, since the 10 of spades lead would not have won any awards. East won the first trick with the jack of hearts and returned the 9. Declarer won the trick with the king and led the jack of diamonds for a finesse. East covered with the king, won by the ace. Next came the ace and king of clubs. If they had split 3-2, there would have been no story. But when they were 4-1, Garozzo was a trick short. His only hope now was to score three spade tricks.

East's spade overcall made it clear that West had one or two spades at most and that the queen was probably in the East hand. If Garozzo had enough entries, he would have led the jack of spades from dummy to the queen and king, then returned to dummy for a spade to the 9. But there was only one entry left to dummy, so Garozzo was forced to play West for the 10 of spades. He cashed one top spade, led a club to the queen, and called for the jack of spades, pinning the ten.

If you haven't read Roselyn Teukolsky's book, "How to Play Bridge With Your Spouse... and Survive," you should immediately order a copy. It's been out of print for some years and was just republished by Masterpoint Press in Toronto. Here's an excerpt from chapter 10, "A Dozen Roses: Disaster Relief."

Roselyn was West, her husband was East, and North-South were the two "most obnoxious" players at the club. Roselyn did not want to set up declarer's spade trick, so she led a heart. "With undisguised glee, declarer won and began to run his clubs." He led seven of them and "by this time I was in a state of extreme misery. Partner's carding had suggested that he held the king of spades and an odd number in the suit." On the last club, Roselyn had to pitch from A-3 of spades, the king of hearts, and the K-7 of diamonds. "I was so agitated by my failure to lead a spade that I failed to make the inference that if partner had held another heart he would have parted with it long ago, and it was therefore 'safe' for me to throw a diamond. Anyway, I made the inspired discard of the ace of spades, watching my partner age a few years as I did so.

"It was when the other small spade in my hand hit the table that my husband lost his sanity. He and his chair lunged backwards. The words that he bellowed at me, at full throttle, are irrelevant (and unprintable). Every neck in the club got whiplash as heads spun around to gape at us. Play was suspended at every table — the show at ours was riveting.

"As you may well imagine, the rest of the evening, played out in icy silence, followed by the rest of the night, was not a great success.

"The roses arrived the following afternoon..."

See the director as soon as possible if you discover an error in your score. The appeal period for a director's ruling expires thirty minutes after the completion of the session.

Jennbridge: Count Your Losers!

Partner dealt and opened 1 spade at the club game yesterday (board 27) and I held:

♠ J74
♥ AQ8
♦ Q102
♣ A964

What is your call?

While I had 13 points, I had 8 losers which meant the hand was not necessarily worth a game-forcing bid. Therefore I decided to start with a forcing notrump and try to get more information from partner before my next bid. I can always put the hand in game, make a 3-card limit raise, or perhaps even veer into notrump.

My fearless (reckless?) LHO came in with a double and Bob, my partner redoubled, showing a good hand. RHO bid 2 hearts and it was decision time. As I had hoped, I now had a lot of information.

For starters, the opponents were probably in big trouble. Secondly, LHO had values. Finally, my partner had a good hand as indicated by his redouble. Clearly we belonged in game, but several factors pointed to a notrump game:

- My hand was a balanced 4-3-3-3 with no ruffing values.
- All of the suits seemed to be adequately stopped.
- The partnership possessed extra values so that as many tricks were likely available in notrump as in a suit contract
- With the heart bid on my right a heart lead was likely.
- The omnipresent and overriding reason: We were playing *matchpoints!* (so that making that 10 point bonus was all-important)

I decided against punishing the relatively inexperienced opponents and my 3 notrump bid closed out the auction. A heart was led and a suitable dummy greeted me:

♠ KQ1098
♥ K3
♦ AK
♣ Q1083

♠ J74
♥ AQ8
♦ Q102
♣ A964

11 tricks were easily available and we were rewarded with a near-70% board.

My LHO held: A/10742/9853/KJ52.

The keys to the hand were 1) staying out of slam and 2) bidding notrump. My partner admitted that if I had started with a 2 club game-forcing bid, it would have been virtually impossible to stay out of slam, and nearly half of the field did, indeed, bid to the slam. (One pair, remarkably, bid and made 6 due to an unlikely endplay. Charlene stripped the red suits and threw her opponent in with the {lucky for her, singleton!} ace of spades who had to then lead away from the king of clubs.)

Don't forget to count your losers!

RHO dealt and passed and I innocently opened 1NT:

♠ 952
♥ AQJ
♦ A1092
♣ A104

Abbe, with a flourish, responded 4♦, a Texas transfer, and I duly bid 4♥. She now bid 4NT, keycard, and I responded 5♦, showing 0 or 3. She now signed off (or attempted to) at 5♥. I found this whole auction unusual, however, and couldn't really figure out what was going on. It did seem to me though, that since I had 3 keycards rather than 0 that I should take another call. So I bid 6♥ and everyone passed.

The ♦ king was led and I did my best to conceal my surprise.

"Good grief!" I quieted my mind with the declaration that I wasn't down yet. I saw that I could take a ruffing finesse against the ♦ queen and be down only one (for what that would be worth).

I drew a couple of rounds of trump and took the ruffing finesse--the ♦ 10 being covered by the queen and ruffed. I drew a couple more rounds of trump and noted with interest as LHO, a very experienced player with thousands of masterpoints, pitched two diamonds. For good measure I drew the last trump and played off the clubs ending in my hand.

I cashed the ♦ 9 pitching a spade as both opponents followed. Was there really a miracle at hand or had I miscounted? I played the ♦ 2 and pitched another spade as everyone showed out. Making 6. The ♦ 2 was my 12th trick!

Abbe was starting a small celebration in her seat and I hurriedly scored up 1430 and jumped up from the table for a walk out into the hallway. Ha! Perhaps I have been in a worse slam but, mercifully, I can't remember it!



A Hand from the Wednesday/Thursday Knockout by Stan Subeck

You hold: S-AJ9852
H-KJT85
D- VOID
C - J2

You open 1H – Partner responds 1NT (forcing) and you rebid 2H
Partner bids 3NT – Your Call?

You open 1S and partner bids 1NT (forcing). After your 2H rebid, partner jumps to 3NT. What should you bid? The immediate reaction of most players is to show your five card heart length by rebidding 4H. I believe it is better to rebid 4S.


Partner's distribution is usually 2-3-4-4.

If he held a decent five card minor, he should have made a 2 over 1 response to 1S. It has been my experience that 6-2 fits play as well or better than 5-3 fits. You keep control of the hand and cannot be tapped out. Also this approach allows you to bid 4H when you have opened 1S with five spades and six hearts. This allows you to reach the correct contract when partner's distribution is 2-2-5-4 with 5 bad five card minor.

At the table, partner made the knee jerk 4H bid.

The opening lead was the King of Diamonds. Partner won with the ace in dummy and pitched a spade.

She ran the nine of hearts to the queen in West. West continued diamonds. Partner ruffed in hand and played a spade to the king and a spade to the ace, planning to ruff a spade in dummy and drive out the ace of trump.

When the queen of spades fell on her left, she knocked out the ace of hearts and made five!

+650 was worth 13 IMPs

Note that the ace of diamonds (good for the worthless pitch of the sixth spade) was a HUGE card on this hand. It saved partner from losing control in the trump suit.

Six diamonds is a good sacrifice against East/West's cold five spade contract... even vul against not.

Notice that if the opponent's lead a club, they will score a club and a heart because the club suit blocks.

As it was, the opening lead was a spade, trumped in dummy. Declarer led a heart from dummy and East made the fatal play of a small heart!! Declarer won the queen, led a middle diamond to dummy's ace, preserving small diamonds for dummy entries.

Declarer ruffed a heart, noting the fall of the jack... drew the last trump and ruffed a spade in dummy. He was now able to ruff out the heart ace, lead a small diamond to dummy, and discard his two clubs on the two good hearts... Making six for +1540.

At the other table, the auction ended in five spades.

Given the cards, the contract was cold...

Winning 19990!!! Or 18 IMP's.

In the end, six diamonds was a REALLY good save!
