Meet the USBF Officers ...



Born in Minneapolis in 1953, Howie Weinstein, USBF President, lived in Minnesota for his first twenty-six years, then on to Chicago until 2001, spending time in Florida and California before moving with his wife Cyndi to Omaha in 2012.

Howie designed computer systems for option clearing firms associated with the CBOE before finally joining many of his bridge peers in trading on the exchange floor from 1984 until his retirement in 2000.

For 15 years, Howie's regular partner was Steve Garner. Howie has captured many NABC firsts and seconds and in world championships has finished 2nd in the 2007 Bermuda Bowl, 3rd in the 2000 Olympiad and 3rd in the 1998 Rosenblum.

Howie has held key administrative positions -- previously chairing the ACBL Conventions and Competition Committee and presently chairing the ACBL Ethical Oversight Committee. He is Vice President of the USBF and Chairman of the ITTC.

One of his favorite bridge experiences was at a Chicago NABC a few years ago, enjoying a glass of wine after the evening session with several others, noticing the nine players at the table represented nine different countries. He adds: "Thought that was very cool and reflected what the spirit and camaraderie of bridge should ideally represent!"

Howie is savoring his retirement -- playing lots of golf and table tennis and plays little bridge other than the NABCs, Trials, and occasional international opportunities.

It is often said that there is nothing new under the sun. That can be surprisingly true of Bridge. The term Informatory Double was developed for Auction Bridge in or about 1911 in the USA. It was so-called because its primary purpose was to "inform" partner of a specific holding, as opposed to a Business Double which was strictly for penalties. All the non-penalty Doubles of today really fall under the umbrella of the Informatory Double, in that they are describing some particular holding.

Even when the then standard weak NT (11+ points into today's terms) was doubled (showing 14+ points) the situation was dominated by the idea of take-out. This probably explains why the name "take-out" has stuck, and superseded the word Informatory. In the 1920s, however, there was a school that thought a better title was the Negative Double. How about that! Indeed, it was usually the case that if you had opened the bidding with 1C, and left-hand opponent had overcalled 1D, then a Double from partner showed both 4-card majors. I wonder if Messrs Roth& Stone were aware. I suspect so: they used the word "Sputnik".

A certain Mr E E Denison of Portland Maine did not like the idea of abandoning the low level Business Double so he developed his own idea of an "Informatory" or "Negative" Cue Bid. The bid of 2D in the above sequence would show both majors. Others took the idea further and used an immediate cue bid of any opponent's simple overcall to ask opener to bid another 4-card, sometimes merely the longer, unbid suit. So the sequence:

would show holdings in both minor suits.

Those were the days, remember, before formal systems or conventions were so widespread, but it is salutary, and humbling, to find that people were exploring ideas that still seem *avant garde* to modern beginners. (Weak twos were common, if deprecated by experts, in the early 1920s.) This informatory cue bid is in use today, in a somewhat similar fashion. It shows "values", which covers a multitude of sins. The older (or should I just say previous) idea of only using cue bids of opponents' suits to show super fits and controls just did not happen often enough.

Another use of such a cue bid was in response to partner's Informatory Double of a minor suit. This meant that responders only 4-card suit was the opponent's, but the hand was too weak to bid 1NT, because even those 4 cards would not provide a stop, and there were no high cards elsewhere. It was usually 4333 shape and a virtual Yarborough. For example:

The 2D bidder would be expected to hold exactly 3 poor cards in each major, and no Diamond stop even though having 4 or more. Any 4-card major, or even good 3-card major, would of course be biddable at the one level.

So if you think of a bright idea for a new use of Doubles, or Cue bids, or any other bid or sequence, check the archives. It is hardly possible to boldly go where no-one has already been.

The UNITED STATES BRIDGE FEDERATION was formed in 2001, for the primary purposes of selecting and supporting United States teams in International Competition and supporting the World Bridge Federation in its efforts to obtain Olympic recognition for bridge. After making a significant effort to promote bridge as an Olympic Sport, including sending a team to the Salt Lake City IOC in 2002, USBF now focuses on selecting teams for International competition, by holding the United States Bridge Championships (aka the International Team Trials) for Open, Women, Senior and Junior teams, and on providing training and support for United States teams in International competition. The USBF was originally formed by the ACBL and the ABA. It now receives support for United States International Teams from the ACBL International Fund and ACBL Junior Fund. It is otherwise self-supporting, with support coming from membership dues, contributions and entry fees for the USBCs... as well as fees from its annual Regional (as this one!!)



The Order of the Bath by David King

The Bath Coup, well known for over 200 years, from the game of Whist, usually occurs at trick one. It is well worth declarer's and defenders' study.

The classic situation is when the defender on lead decides to lead the King from a holding of K Q 10 x, and maybe more. This is often a good lead. If partner has the Ace, then tricks can be cashed without setting up some for declarer. If declarer has the Ace, however, it all depends on the whereabouts of the Jack. Consider these four examples, one shown in each suit:



First, the bad news. In the Spade situation, defender will no doubt regret the lead. Declarer will win with the Ace and still have the suit stopped, with the Jack in dummy. Too bad, but that is life. Let us ponder, however, the situations where dummy does not have the Jack.

The classic position is in the Heart suit. Declarer simply allows the King to win! This is the Bath Coup. If West continues the suit, then declarer takes two tricks. If defender changes suit, declarer likely gains a tempo, and the suit is still stopped. Although given the status of a coup, this is really just self preservation on declarer's part. Should the Ace win the first trick, then whenever East obtains the lead, a Heart continuation will allow West to win the remaining tricks in the suit. So as declarer, you do not have a difficult decision. Just do it! It is the defenders who are in difficulty.

Put yourself in West's position for the Diamond or Club situation. Let us assume, for the moment, that the King has been led and wins. What should West do next? If South has A J x, then a switch is advisable. If South has just the Jack (as in Diamonds), or just the Ace (as in Clubs), then a continuation is safe. How is West to know? The answer is that East must tell West. But how?

A nod or a wink is not allowed!

The opening lead of a King, particularly in No Trumps, should have told East that West also holds the Queen. It should also imply holding at least one of the Jack, or the ten. Holding neither, then West would often choose to lead something else.

Thus in the Diamond situation it is quite safe for East to overtake the King with the Ace and return the suit. In the Club situation, East simply plays the Jack, then West can safely continue. In the Heart situation East is unable to do either, and so plays a plain card. Conventionally, for some players, this is the lowest with 3 cards, a higher with two (or four), but this is a finer point. The key is that if East holds either the Ace or the Jack, it is played. If holding neither, then perforce East cannot play either. This is a typical example showing how the game of Contract Bridge depends to a great extent on negative inference. "No have, no can do!"

So, to summarise, the order of priorities for you as leader's partner, to counter the Bath Coup is: first, if the Jack is not in dummy and you hold the Ace, overtake the King and return the suit; second, if you have the Jack play it on the King, to show that declarer does not have it; and finally, with neither of these options available, try to show how many cards you hold in the suit.

2015

The exact dates and location of the 2015 World Championship has not been set, but we anticipate that it will be in September or October. The 2015 Open USBC will select USA2 for the Bermuda Bowl. The 2015 Senior USBC will select both teams for the Senior Bowl. The 2015 Women's USBC will select both teams for the Venice Cup.

2015 Women's USBC

The 2015 Women's USBC will be held at the Bahia Mar Doubletree, Fort Lauderdale, starting on Sunday, April 12th and probably ending on Saturday, April 18th.

2015 Open USBC

The 2015 Open USBC will be held at the Hyatt Regency in Schaumburg, IL, starting on Friday, May 8th and probably ending on Sunday, May 17th.

Opening Lead: 6

One of the most popular conventions is the splinter bid. This bid shows a singleton or void and four-card or longer support for partner's suit. In today's hand, from a Bermuda Bowl, the normal splinter bid by North over South's 1 opening is 4 . But North-South were using an advanced version of splinters, where the direct splinter shows a void in the bid suit, while a delayed splinter (3NT) shows an undisclosed singleton. After 3NT, South had the option of bidding 4 to ask partner where the singleton was. When North next bid 4 , he revealed a singleton diamond.

Over 4., South saw wastage in diamonds. The king-jack of diamonds were, for the most part, valueless, so he signed off in 4. Where was his thinking flawed?

Picture South with the same hand and four little diamonds. South would say to himself: "Wow, I have nothing wasted in diamonds, and all my cards are working." Then he would cuebid 4, moving toward a slam.

The "wastage trap" occurs when the partner of the splinter bidder has wastage but also has extra values. Take away South's king of clubs and South would be right to sign off in 4. But here South must say to himself, "I have wastage, but I also have a full opening bid of working cards."

Six spades was bid and made at some other tables, after declarer ran the ten of diamonds to the queen and later ruffed out the ace of diamonds. Declarer was able to ruff another diamond in dummy and discard the club loser on the king of hearts.

While playing OKbridge, I had just finished a 3NT contract, making, when someone sent me a message saying: "We beat 3NT on that one!" So now while playing the next hand I had to look at the previous hand to follow the play by play from the other table.

When I was declarer, I received a low diamond lead, which I won in dummy with the jack. That gave me two entries to finesse hearts twice and that's how I scored nine tricks (two spades, three hearts, two diamonds and two clubs).

But at the other table, West led a spade. Declarer won the first trick with the king, led to the ace of clubs and ran the ten of hearts to the king. West returned a spade to the ace and declarer tried to sneak through a diamond to the jack. But West went up with the ace of diamonds on the lead of the 7 and returned a diamond. Declarer was stuck in his hand and had to lead hearts out of his hand, for down one.

At least we don't call it a "sack" like people from the southern U.S.

7. **Real Quick:** When you hear Wisconsin folks ask you for a favor and then add "real quick" or "really quick" to the end of it, we aren't talking about speed. We're simply trying to make it seem like the favor is no big deal.

For instance, someone might ask, "Can you stop at da store real quick before you come home? I got a meatloaf in da oven."

- 8. Once/One Time: Have you ever wondered why we say "come here once" or "let me see dat one time"? It's about sounding less aggressive or like you're not demanding too much. It's yet another way we get the friendly vote.
- 9. **Bubbler:** I've been made fun of a time or two for asking where the bubbler is when I was outside of my home state. Most people will refer to it as the drinking or water fountain. If you're interested to know more about this specifically, my husband has written some great insight into the real reason why we call it a 'bubbler' in Wisconsin and who else does too. Check it out!
- 10 'N So: You've probably heard this before, 'n so? Which is simply a reduction of the phrase "Isn't that so"? My classic Wisconsin grandma and her sisters use this expression a lot. In fact, I think I've heard them say all 10 of these words and phrases!

So - dere ya go, eh? 10 silly things we say in Wisconsin!
