# Where to Eat in Lake Geneva

Lake Geneva has several good eateries.

If you do not have a car, the *Grand Geneva Resort and Spa* offers some excellent choices for your lunch and dinner pleasure.

First, there is the *Geneva Chophouse*. Specialties of the house include chicken, steak, and seafood. The view from the restaurant is beautiful and the food is a fine match for it. The *Chophouse* is open for lunch Monday through Friday 11:30 p.m. to 2:00 p.m. and dinner 5:00 p.m. to 10:00 p.m. Monday through Thursday, and dinner 5:00 p.m. to 11:00 p.m. Friday and Saturday. A Sunday brunch is served from 10:00 a.m. to 2:00 p.m. Closed Sunday evenings.

Second, there is *Ristorante Brissago*, an Italian restaurant on the second floor of the resort. *Brissago* specializes in northern Italian cuisine. There is an extensive wine list, and the prices are moderate. The food is excellent. *Brissago* is open for dinner 5:00 p.m. to 10:00 p.m. Wednesday through Sunday. Closed Monday.

Last, there is *The Grand Café* in the hotel lobby, which offers casual café-style dining featuring sandwiches, burgers and a daily breakfast buffet. The *Café* offers bridge player specials daily. Watch the *Ruffing It* for more information on these. The restaurant is open for breakfast, lunch and until 10 p.m. for dinner daily.

If you have a car or don't mind a short cab ride, here are some other excellent alternatives:

*The Grandview at the Geneva Inn* – This restaurant offers elegant, romantic atmosphere combined with fine gourmet dining featuring seafood, steak, pasta and daily specials. It is located on Highway 120 S. and is open for lunch from 11:30 a.m. to 2:30 p.m.; Sunday brunch, 10:30 a.m. to 2:00 p.m.; dinner from 5:00 p.m. Monday through Saturday, 3:00 p.m. Sunday. An extensive wine list compliments the menu.

*Club House Inn* – Located at W3731 Club House Dr. on the north shore of Lake Como, this American restaurant features barbecue ribs, lamb chops, fresh seafood, and certified Angus steaks. It is open for dinner from 5:30 p.m., Wednesday through Sunday. Prices are moderate.

*Houlihans Restaurant* – *Houlihans* is located at 111 Center St. (at the Cove of Lake Geneva across from Geneva Lake.) It features the standard *Houlihans* menu with baked potato soup, steaks, fajitas, steaks, chicken, seafood, pasta, and is open for lunch and dinner from 11:00 a.m. to 11:00 p.m. Sunday through Thursday and 11:00 a.m. to midnight Friday and Saturday. The bar is open nightly until 1:00 a.m.

▲ *Kirsch's at the French Country Inn* – Located on Highway 50 overlooking Lake Como, this restaurant offers elegant gourmet cuisine. Signature dishes include Hibachi grilled Chilean sea bass, roasted Kona crusted Chateaubriand. There is an authentic New Orleans style brunch on Sunday from 11:00 a.m. to 2:00 p.m. Otherwise, the facility opens for dinner Monday through Saturday at 5:00 p.m.

*Su-Wing Chinese Restaurant* – Located at 743 North St., this Chinese restaurant opens at 11:30 a.m. (closed Monday) and offers dine-in, carry-out, and even a drive through pick up.

*Popeye's* – Located at 811 Wrigley Dr. across from Geneva Lake, this "in" place has an outdoor barbecue pit for rotisserie chicken, lamb and pork. It has great broccoli-cheese soup, good hamburgers, and interesting salads. *Popeye's* is open from 11:30 a.m. to 8:30 p.m. Sunday through Thursday, and 11:30 a.m. to 9:30 p.m. Friday and Saturday.

*Pizza Hut* – Located at 801 Williams St., this well-known chain features its standard menu of pizza, pasta, salads, and bread sticks. Open from 11:00 a.m. to 10:00 p.m. Sunday through Thursday; 11:00 a.m. to 11:00 p.m. Friday and Saturday.

*Original Chicago Pizza Company* - Located in downtown Lake Geneva at 150 Center St., 414-248-8544 has great pizza, reasonable prices, and fast service. Open at 11:00 a.m. daily, the restaurant serves both lunch and dinner. The prices are reasonable and the pizza is quite delicious.

*The Red Geranium* – Located next door to the Grand Geneva, *The Red Geranium* offers an excellent menu with a variety of selections including lamb, pork, beef, chicken and fish. They also feature a daily pasta special. The food is among the best in Lake Geneva. It is pricey for the area but well worth the trip. The appetizers are especially enticing. Be sure to leave room for dessert! Everything at *The Red Geranium* is delicious. Try to go here on a night when you have ample time between sessions. The service is laid-back and you will need the time for your dinner.

Tannah Hirsch, of Travel With Goren, tells a sad tale, sitting East on today's hand, from a 50-cent rubber bridge game in New York. Over 1♥ he bid 2♥, Michaels, showing spades and a minor. South then put a jolt into the proceedings with a jump to 6♦. Perhaps West should have bid 6♠, taking out insurance, but he passed and led the king of hearts.

The sad story is that Tannah held the highest heart outstanding, the six. If he had held the 2, it would have been clear to West that Tannah held a singleton, because he would always follow suit with the higher of a doubleton. If Tannah held the singleton 3, there was a chance that declarer would make a mistake and follow with the 2, which would allow West to be sure that partner held a singleton 3. But following suit with the 6 gave West no help, and West was reluctant to continue with the ace of hearts, which he thought South might ruff.

West switched to a spade at trick two. It was a reasonable play. After all, where was the second heart going if South started with two of them? The answer is: on the ace of spades. But South did not rate to hold the singleton king, did he? Perhaps a compromise by West would be to lead a low heart at trick two. That way, if partner held a singleton, he could ruff the trick and if partner held a doubleton, the low heart lead would give away only one trick. This "compromise play" would not have been successful.

Ron Klinger, of Sydney, Australia, discusses an interesting idea in the April issue of Australian Bridge Magazine, in his "It's Your Lead" column. When you haven't a good lead against a low-level notrump contract (or 3NT for that matter), and your hand is weak, you want to find partner's suit. But to do so, you must review the auction and think about why partner did not make a bid.

This hand was played in the "Gold Coast Pairs." The North-South pair was playing weak notrumps, so the rebid of 1NT showed 15-17 points. West held a weak hand and could be sure that East held a good hand. So why hadn't he bid? One reason might be that his best suit was diamonds. But if you had to guess between leading a spade or a club, which would it be, and why? The club lead is a better chance, because if East held a spade suit, he might have overcalled 1♠ or doubled 1♥ for takeout. So Bruce Neill, our hero, led the 4 of clubs and defeated the contract when declarer misguessed diamonds. (Yes, a diamond contract may have been better, but declarer can make at least 120 in 1NT, despite the misguess in diamonds, after a traditional "when in doubt, lead a major" spade lead by West.)

## VIENNA VISION FROM JENNBRIDGE BY JENNIFER JONES

Here's a cute hand I picked up the other night, playing a few hands online with the Gib robots before I went to bed.

♠ Q  
♥ A9  
♦ AK9xx  
♣ AOxxx

I opened 1D, my robot partner responded 1 heart. I jump shifted to 3 clubs and pard bid 3 spades, probably natural. Not having much luck bidding delicately with the robots, and just wasting time anyway, I jumped to 6NT. I got a spade lead and saw a suitable dummy:

♠ AJxx  
♥ Kxxxx  
♦ QJ  
♣ Kx

♠ Q  
♥ A9  
♦ AK9xx  
♣ AOxxx

It looked like an easy 12 tricks as I ducked the trick around to my queen. I played the QJ of diamonds and then started on the clubs which broke 4-2. About this time I noticed that there should be a squeeze for 13 tricks--LHO would need to guard spades and hearts while RHO needed to protect clubs and hearts.

But wait. Maybe I blew it.

Yes, I should have cashed the spade ace while I was on the board--A Vienna coup! Failing to do so created a position such that the squeeze wouldn't operate. Here are the last few cards as they **should** appear if you are alert and up to executing this great play.

(From The Bridge World Glossary: *Vienna coup:*  
*the cashing of one or more winners to avoid blockage in a squeeze position.*)

♠ J  
♥ Kxx  
♦ ♦  
♣ ♦  
♠ ♦  
♥ A9  
♦ 9  
♣ x

Having had the vision to cash the spade ace while on the board, then, when the last diamond is cashed, LHO hangs on to the spade king and discards a heart. Your spade has now served its purpose and you discard it from the board. RHO hangs on to his last club (in order to prevent the club in your hand from becoming a winner) and also throws a heart. Now the ace and king of hearts collect the remaining hearts, making your last heart on the board a winner, and you have all 13 tricks.

LHO: Kxxx/Qxx/xxxx/xx  
RHO: xxxx/Jxx/xx/Jxxx

If you don't cash the ace of spades first (discarding a club), you don't have an effective discard from the board on your last diamond, whereas it is easy for the opponents to discard. (Try it--you'll like it!)

# AN INTERESTING HAND AT THE CLUB

Kathy and I were having a ho-hum game at the club Friday until the last hand of the day. With neither side vulnerable, I was dealer and picked up:

♠ K87  
♥ AT5  
♦ AKQ765  
♣ J

I opened 1 Diamond. LHO passed, and Kathy bid 2 Clubs, a game force. How should I proceed?

I had several choices. I could rebid 2 Diamonds, 2NT, 3 Diamonds or 3NT. I decided that a NoTrump bid would be best, since I didn't want to bid diamonds and have partner bid NoTrump, which could wrong-side the contract. If I had been playing with Jenn, I would have bid 2NT since we discussed the pros and cons of bidding 3NT in this position and decided that it took up too much space. However, I hadn't played with Kathy in a long time, and decided to make the value bid of 3NT, which showed about 18-19 HCP. (I only had 17, but with the great suit and jack in partner's suit, I felt I could upgrade.) Now Kathy bid 4NT, inviting slam. Since it was the last board, and not much had been happening for us, I said "what the heck" and just took a shot and bid 6NT.

LHO led the Jack of Diamonds, not a good sign. When the dummy came down, I was looking at:

♠ JT  
♥ Q642  
♦ void  
♣ AKQ9643

♠ K87  
♥ AT5  
♦ AKQ765  
♣ J

Well, I wasn't going to make it by running diamonds, but I had a chance because Kathy gave me 7 good clubs. The suit looks solid, but because she had no entries outside, I had to hope clubs were 3-2 or there was a stiff ten, since I had to overtake the Jack to get to them.

Assuming the clubs ran, I had 11 tricks: 7 clubs, 3 diamonds and the Ace of hearts. The 12th trick had to be in spades, since if I lost a heart they would cash

the Ace of spades for down one. So I had to win trick one and immediately run the clubs, coming down to

♠ K8  
♥ A  
♦ AK  
♣ none

and hope I could guess the spades.

Now psychology came into play. The clubs split 3-2, so I ran them. During the run of the suit, LHO played high-low in spades. I asked what their carding agreements were, and they said standard. So, should I believe this as an honest signal, assume he was trying to fool me, or just ignore it and flip a coin?

LHO was a good Flight B player. If he had been an expert, I would have had a real conundrum. He would know I wouldn't expect an honest signal, so he might just give me one, since I'd likely assume he was lying! I didn't think this opponent would play such a deep game, but would he try to fool me, or perhaps give an honest signal to help partner with discarding? Finally, I decided on the latter, ran the spade jack and was rewarded when he won it with the Ace. 6NT bid and made, for 8 out of 8 matchpoints.

### An Unconventional Nativity...

# BOOK REVIEWS FROM SALLY SPARROW'S BLOG SITE...

## 1. *Breaking the Bridge Rules: First hand play* by Barry Rigal

I start with this one because it is the first of a planned four-book new series on cardplay. Rules are made to be broken, and bridge is no exception. This book deals with situations where the player on lead – defender or declarer, at the start of the deal or in the middle – needs to do something that is ostensibly 'breaking the rules'. Not, obviously, the rules of bridge itself, but the well-tried adages that every player is taught – the rules of thumb that work in a lot of cases. Knowing when to break those rules is one of the marks of an expert player.

I am pretty good at breaking the rules, but alas, I am not the author of this book. Nor am I any sort of bridge expert. Here is a little bit about the author:

**Barry Rigal** (New York) grew up in the UK and is a professional bridge writer and commentator. He contributes regularly to various magazines, and is the head VuGraph commentator at World and European events.

## 2. *Bridge at the Enigma Club* by Peter Winkler

Robert Tischman is just looking for a game of bridge, but when a mysterious woman persuades him to play in a two-session event at the Enigma Club, he gets much more than that. This is a book that can be enjoyed on several levels:

- 1) as a fun bridge novel with lots of great deals;
- 2) as a glimpse of what the game might be like if technology were applied to it with more imagination;
- 3) as an exposition of the author's ideas on encrypted bidding and encrypted signals – bids and plays where in full compliance with the Laws of Bridge, partners can exchange information that cannot be deciphered by their opponents.

**Consumer Warning:** the methods represented in this book, though fascinating and ingenious, are illegal in many bridge jurisdictions. [This message will self-destruct in 5 seconds.]

**Peter Winkler** (Hanover, NH) is a former cryptographer who now teaches mathematics and computer science at Dartmouth College. He originated the idea of encrypted signals some twenty-five years ago, and has been fighting to legalize them ever since.

## 3. *Deadly Hold-Up* by Jim Priebe

Sounds ominous, doesn't it? Well, see for yourself. Art Fraser, the bridge-playing detective who made his debut in *Takeout Double*, has left Buffalo and moved his new family to Florida, where he is setting up as a private investigator. However, he's soon called back north to help the bridge authorities in Boston, where a robbery at the Fall Nationals has left one man dead and a whole lot of money missing. The local homicide cops are less than overjoyed to have Fraser involved, but they're also struggling to understand the ins and outs of the bridge tournament world. The two sides work out an uneasy arrangement as the mystery deepens.

**Jim Priebe** (Toronto) is a Canadian international bridge player and the author of two previous Art Fraser books, as well as two technical bridge titles. He is a retired executive, who divides his time between bridge, golf, and grandchildren.

## 4. *The Pocket Guide to SAYC* by Ned Downey and Ellen Pomer ('Caitlin')

Using the same format as *The Pocket Guide to Bridge*, this book will provide a handy pocket summary of the popular SAYC bidding system. In a concise but readable manner, it goes over the basic ideas of SAYC, which is the most popular natural system for online bridge players around the world. The contents are based on *Standard Bidding with SAYC*, by the same authors.

**Ned Downey** (Hawaii) and **Ellen Pomer** (Toronto) are experienced bridge teachers and partners in the 'Bridge Forum' web site. Ned is also teaches bridge via the Swan Games online playing site Ellen is well-known on the Internet under her handle 'Caitlin', and regularly writes for various magazines on Internet bridge.


